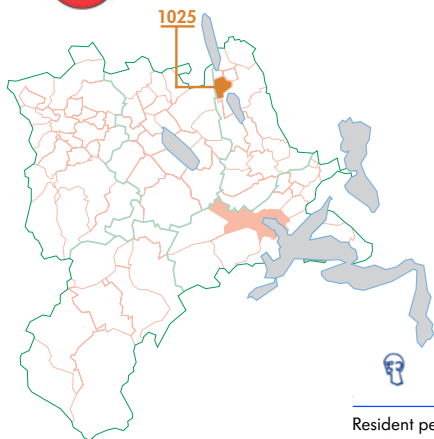




Ermensee

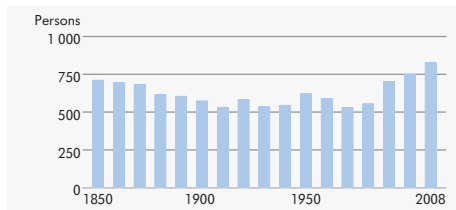
