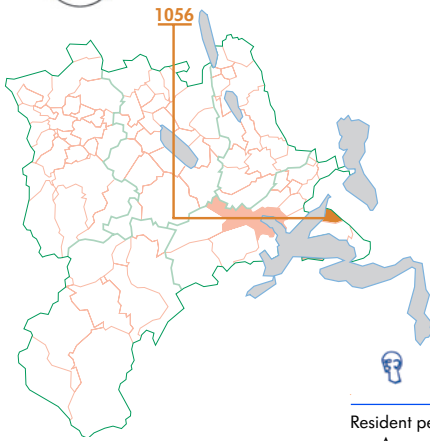




Greppen

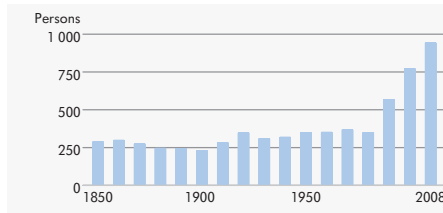
